Cases have involved on-site attendance to identify possibly sources of common grain insect and cockroach infestations, negotiate with port/ quarantine authorities and advise on suitable infestation treatments including insect trapping, insecticide spraying and fumigation (involving aluminium phosphide (phosphine), methyl bromide and sulphuryl fluoride).

He has also been involved in investigating historical commodity prices to determine whether claim values are accurately calculated and involved in mitigating loss of damaged cargoes by liaising with potential salvage buyers.
